- **Welcome**

Dr. Pimentel began the meeting at 9:00 a.m.

- **Case Report Updates:**

- **Point of Contact updates**

- Employee:

- Number of COVID positive employees: 1

- Number of employees in quarantine for direct exposure: 0

- However, we had some that were asked to stay home. They did not have direct contact, but wanted to monitor for symptoms.

- Student:

- Number of COVID positive students: 2

- Number of students in quarantine: 2

- Guest:

- There are no reported positive cases from guests.

- **Screening**
 - The Team discuss the need to add a length of time to the first question on the employee/student/guest COVID screening form. The team agreed to the following language. “Have you been in close contact with a confirmed case of COVID-19 or tested positive for COVID-19 within the last 14 days?”
 - The Team previously discussed the need for faculty to have access to student screening clearance. Please provide a list of faculty needing access to the President’s Office.
 - Each morning, student athletes receive a link by text from Healthy Roster. Once athletes complete the screening they either received a green check mark to access campus or an alert not to report. The alert of denied campus access also goes to Steve Cornelison and the athletic trainer.
 - We are looking at ways to best monitor guest athletes COVID screening.

- **Health Department Guidance**

Jackson- Madison County Regional Health Department was asked to provide guidance on the following scenario.

Scenario: Students are in labs, wearing PPE and social distanced for more than an hour. If one of the students test positive for COVID, are the other students considered exposed.

Jackson-Madison County Regional Health Department’s Response: If students were socially distanced, at least six feet with PPE, they recommend telling the class there is a positive case and asking students to self-monitor for symptoms. There is no need to quarantine anyone, unless they were closer than six feet for more that 10-15 minutes.

- **Temperature Kiosks**

JSCC has purchased 25 kiosks with grant funding. The Team discussed the use of the kiosks, deployment, and temperature settings. For now, the kiosks will be stationed in office areas across campus as a trial run on temperature readings. The kiosks will not be networked and information will not be stored. A log will be placed on the machine for employees to voluntarily log a temperature reading during the trial period. The log will not ask for personally identifiable information. Dr. West Sands made a motion that was seconded by Dr. Larry Bailey to use 99.6 F as the temperature threshold on the kiosks. All were in favor with no opposed. The motion carried.
